

## **SummerQuest is back for 2021!**

We are THRILLED to announce that SummerQuest registration is ready to open! SummerQuest will take our teens and tweens out on the road! Our weekly field trip-based program will be running from July 12th to August 13th this summer, and will be going on hikes, exploring different towns (and the occasional pit stop for ice cream!), visiting museums, riding the rides at Canobie and so much more this summer! SummerQuest is open 8:00 a.m.-3:00 p.m. We invite you to check our website for all information on SummerQuest.

### **Schedule:**

SummerQuest will run from July 12th-August 13th. Participants register for each week individually. There are no partial week sign ups.

### **Payment:**

All Payments for SummerQuest are due at registration. Your registration will not be complete until payment is received. Paying online will ensure your spot is saved.

Registration will close June 1st to account for staffing. **There are no refunds for tuition.**

**At Registration, please make sure you have added the Registration Fee to your cart. It is listed below Week 5.**

Please read below for all new information on SummerQuest for the 2021 Summer.

### **ARRIVAL/DISMISSAL**

During drop off and pick up, we will ask that you stay outside at a distance of 6 feet until it is your turn to drop off your child either at the CommEd Building, or at your outdoor program. Please plan for time in the morning for drop off, as there will be additional steps this year. We will ask you to present the Daily COVID Drop Off Form stating that your child has no symptoms or known exposure of COVID-19. This form will be required to drop off your child EVERY day. (This form can be found on our website. Please print out multiple copies.)

Each day at drop off, your child will be required to have their temperature checked by the Supervisor on duty or the Nurse. A child with a fever over 100 degrees will not be permitted to stay at any of our Summer Programs. If your child has a fever over 100 degrees, you may choose to stay with them and retest after no longer than 5 minutes in a socially distanced area. If their temperature is reduced after 5 minutes naturally, they may be permitted to stay. The Nurse/Supervisor of each program will follow up with any child during the day to make sure their temperature has not changed.

For dismissal, if your program is indoors, please use the buzzer at the front door of the CommEd Building. If your program is outdoors, please return to the drop off point of your outdoor program.

Drop off and dismissal will take place outside regardless of the weather.

**(NEW) Chelmsford Community Education's COVID-19 Policies**

If Chelmsford Community Education must cancel a program due to an onsite COVID exposure, or your child is sent home because they were a close contact to a positive COVID case at one of our programs, you will receive a refund for any unused days during the mandatory closure or quarantine period (excluding registration fees if applicable). If your child is deemed a close contact or is diagnosed with COVID from exposure outside of Chelmsford Community Education programs, no refunds will be issued.

All COVID-19 protocols set forth by the state and federal government will be enforced. Registration will be capped in all programs to assure we are able to meet the required space to allow for social distancing. Once registration is full, you can add your child to our waiting list.

Activities are subject to change if the state or local BOH updates or revises any COVID-19 guidelines, policies, or restrictions during the summer.

Masks will be worn as dictated by the current policies of the CDC and BOH, and within the expectations of any establishment we are visiting.

Mask Breaks will happen when children are eating snacks or lunch, and children will be separated 6 feet from each other or outside.

Gaiters, and masks with vents are not acceptable masks for SummerQuest.
